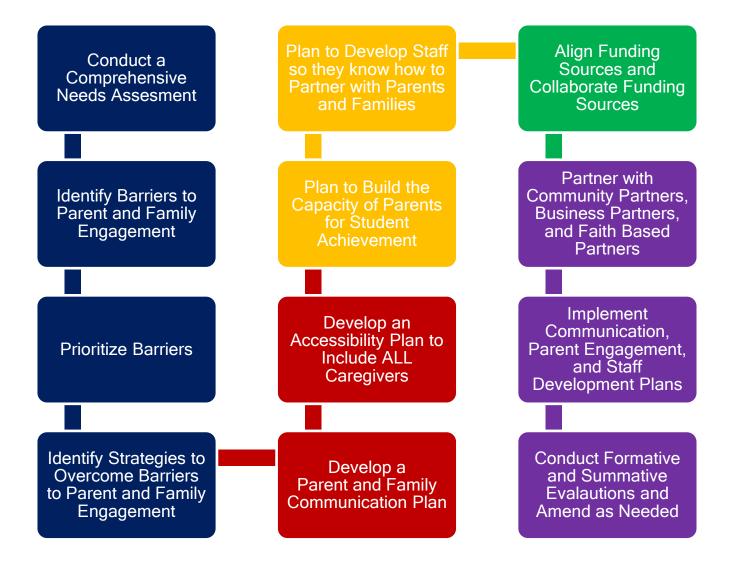
## **OVERVIEW**
